Fourth offence	1 day in school detention/suspension. Parents and student sign a warning letter.
Fifth offence	"Fourth offence" consequences applied. Student Study Team Referral. Behavior intervention plan set in place.
Sixth offence	Parents and student sign a warning letter. Conditional enrolment for the next academic year.

Substance abuse or smoking in the school premises

Third offence	2 days out of school suspension. Parents informed. Expulsion.

Bringing mobiles or using radios, recorders, in the school without prior permission and only for educational purposes.

First week	Homeroom teacher explains the rules and consequences to the students. "No mobile phone" policy inside the school is explained clearly to the students. Students sign a code of conduct with the homeroom teacher.
First offence	Parents are also informed through "students' hand book" Verbal intervention and guidance by the teacher.
Second offence	Verbal intervention and guidance by the teacher. Teacher refers student to the behavior coordinator for intervention. One to one session with the Behavior Coordinator. Device is detained until the end of the day. Behavior Coordinator informs parents. Device is given to student.
Third offence	Detention from session-Zero participation. Parents called for the meeting with Behavior Coordinator. Parents and student sign a warning letter. Device is given to parent.
Fourth offence	Detention from sessions-Zero participation. Parents called for the meeting with Behavior Coordinator. Parents and student sign a warning letter. Device is given to parent.
